Subject to the above warranty, if applicable and IN CONSIDERATION of being permitted to participate in kayaking, ebiking and/or hiking activities, I, the Undersigned participant, confirm I have read, understood, acknowledge, consent to, and agree with, the following: ACKNOWLEDGEMENT I, the Undersigned participant, am aware and acknowledge that: there are inherent risks, dangers and hazards associated with outdoor activities including but not limited to kayaking, ebiking and hiking; participation in such activities and / or use of all associated equipment may result in injury and / or death and / or property damage; risks, dangers and hazards may arise from foreseeable or unforeseeable causes including but not limited to the weather, reservoir, river, water level or other conditions, risk of falling out of a kayak or drowning, bike collisions, trips and falls, dangers or hazards which are inherent in recreational water activities which take place in an outdoor environment; such risks, dangers and hazards may also be caused by the negligence of Barossa Outdoors and any of its owners, officers, agents or by other participants or myself or by accidents, breaches of contract, the force of nature or other causes; any injuries received / sustained may be compounded or increased by the negligent rescue / medical operations or procedures of Barossa Outdoors, myself or others; I am aware and acknowledge, during a self-guided tour I will be conducting the outdoor activity without any supervision being provided by Barossa Outdoors; I am aware and acknowledge, I will be responsible for my own safety and wellbeing and the safety and wellbeing of participants under the age of 18 years; and have read, understood and signed Barossa Outdoors' Terms and Conditions relevant to my planned activity; have advised Barossa Outdoors of an Emergency Contact and completed the Medical Form and submitted same by mail, in person, online or via email; if applicable, have obtained consent from parents or legal guardians of participants under the age of 18 years to participate in an activity where I am not the parent or guardian; and if applicable, will complete Barossa Outdoors' 'Accident, Incident and Injury Report form' (available upon direct request to Barossa Outdoors and submit to Barossa Outdoors in the event of an accident, incident or injury occurring during the hire period; and SUPERVISION AND PARTICIPANT'S WARRANTIES I agree to abide by, comply with Barossa Outdoors' Terms and Conditions, and any direction or instruction given to me by Barossa Outdoors prior to the commencement of, and / or during, the activities. I warrant that I will not engage in any reckless, negligent, or foolish behaviour or any other behaviour that is likely to cause injury to me or any other participant or damage to Barossa Outdoors' equipment. I warrant that I am medically and physically fit and able to participate in the activities. I acknowledge I must, and agree to, disclose any pre-existing medical or other condition, injury or concern that may affect the risk that either I or any participant under the age of 18 years have suffered prior to the commencement of the activity and that I will notify Barossa Outdoors of any injuries, illness or concerns that may arise during an activity.
